PAYMENT ARRANGEMENTS

School Tuition

School Tuition applies to children in the Primary and Middle Schools and also children in Children's House who are prep-aged or older. If your child was born between July 1, 2020 and June 30, 2021 they will be considered prep-aged in 2026.

- All fees and charges are billed on account at least one week prior to the commencement of each term.
- School fees are due and payable on the Thursday of the first week of each term unless a payment authority is in place
- If a payment authority is in place, fees may be paid termly, monthly or fortnightly as per the School Tuition 2026 Payment Schedule via Direct Debit, MasterCard or Visa.

Long Day Care Fees

Children in the Montessori Independent Toddler Community and children under prep-age in Children's House are considered to be attending Long Day Care.

- All Long Day Care Charges are invoiced fortnightly in arrears via SmartCentral
- The preferred payment method is via direct debit (bank account or credit card).
- If no direct debit authority is in place, fees are due within seven days of invoice
- BMS charges for public holidays and the Australian Government accommodates this process by also paying a Child Care Subsidy for this 'absence day'.
- NB: Parents who do not collect their child within our normal hours of operation will be charged \$15 for every block of 10 minutes thereafter

Outside of School Hours Care (OSHC) / Vacation Care

- All OSHC fees are invoiced fortnightly in arrears via SmartCentral
- The preferred payment method is via direct debit (bank account or credit card)
- If no direct debit authority is in place, fees are due within seven days of invoice
- NB: Parents who do not collect their child within our normal hours of operation will be charged \$15 for every block of 10 minutes thereafter.

WITHDRAWAL POLICY

The enrolment contract (refer to Clause 6) states that parents are required to give the principal **one full term's notice** in writing when a student is to be withdrawn from BMS, either for a short-term withdrawal or for cancellation of enrolment.

- To leave at the end of Term 1, 2026, notice is required by Friday 11 December 2025 (T4 end.)
- To leave at the end of Term 2, 2026, notice is required by Wednesday 1 April 2026 (T1 end.)
- To leave at the end of Term 3, 2026, notice is required by Thursday 25 June 2026 (T2 end.)
- To leave at the end of Term 4, 2026, notice is required by Friday 18 September 2026 (T3 end.)
