# MURRAY EVANS SPORTS AND AQUATIC CENTRE MEMBERSHIP FORM

Patrons are reminded that the complex forms part of the Somerville House School for Girls. Members of the public are asked to abide by some of the policies of the School whilst on the property. To ensure the Centre is able to provide a high level of service in a safe, healthy and pleasant environment for all, we ask our members and patrons to comply with these Terms & Conditions. All terms & conditions have been established to ensure maximum enjoyment and usage of the Centre by all members & patrons. On entry to the Centre, you will be referred to as a "Member" or "Patron" and have the usage rights and obligations as detailed below.

- 1. Legally Binding Agreement** Members/Patrons understand that this agreement is legally binding whether my use of the Centre and its services is determined on a membership or casual basis. Terms & Conditions are subject to change at any time.
- 2. Reception & Access**
  - (a) All Members/Patrons must swipe or present their card at reception every time they attend the Centre.
  - (b) Members/Patrons must advise any change of details, eg. address, phone number etc.
  - (c) The facilities are available to Somerville House Students, the general public and not exclusively for Member/Patrons.
- 3. General Conditions of entry**
  - (a) We will refuse entry, or request any person to leave the premises if the person:
    - (i) is abusive or uses offensive language or whose behaviour is threatening or
    - (ii) is under the influence of drugs or alcohol
  - (b) No smoking permitted in the centre
  - (c) Parents to watch all lessons from designated areas.
  - (d) It is the responsibility of the Member/Patron to advise staff of any serious or pre-existing injuries or medical conditions before participating in any activity.
  - (e) Pets or animals are not permitted in the centre with the exception of guide/companion dogs.
  - (f) The use of any type of camera (including mobile phone cameras) is strictly prohibited. The use of any photography, audio or video equipment must be authorised by management.
  - (g) There is to be no sunbathing around the pool at any time.
- 4. Fitness Centre & Group Exercise Area's**
  - (a) Members/Patrons MUST keep torso region covered at all times.
  - (b) Members/Patrons MUST carry a sweat towel and wipe down all equipment after use.
  - (c) Weights MUST be returned to their correct place after use.
  - (d) Correct training attire and runners to be worn in the fitness centre – NO jeans, work clothes, boots, sandals, thongs or clothing that is likely to cause offence to others.
  - (e) No person under the age of 15 is allowed in the Fitness Centre unless supervised.
  - (f) No food allowed in the Fitness Centre. Personal training is available as an additional service. Only employed Personal Trainers may be used in the Fitness Centre. Unauthorised use of a non-Somerville House employed trainer may result in a cancellation of membership.
- 5. Swimming Pool**
  - (a) No creams, soaps or oils allowed in the pool.
  - (b) Correct training swim attire only in pool. Swimwear must be of a training type design.
  - (c) Children are not allowed in the pool area without parent/guardian supervision.
  - (d) Dedicated areas of the pool are closed to members/patrons while school lessons and squads are being conducted. (refer Lane Availability)
- 6. Hours of Operation/Services Offered** The Centre reserves the right to vary, add, or eliminate from time to time any of the particular facilities, entitlements or services provided by the Centre. Please refer to current operational information such as the Lane Availability schedules displayed within the Centre or on the Centre's website.
- 7. Unavailability of Facility or Services** Members/patrons agree to accept the fact that a particular facility or service within the Centre premises may be unavailable at any particular time due to a prior booking, mechanical breakdown, fire, act of God, condemnation, catastrophe or any other reason. Further, members/patrons agree to not hold the Centre responsible or liable for such occurrences.
- 8. Cancellations/Refunds** The Centre reserves the right to cancel this membership agreement and request return of membership card at its discretion. Reimbursement of any unused portion of your membership/multi pass is at the discretion of the Centre Manager and, if granted, will be made less an administration fee of \$10. Applications for refund of a membership may be granted on the basis of:
  - (a) A medical condition that precludes further participation in any activities included in the purchased membership (and a medical certificate is provided)
  - (b) A member/patron relocates residence more than 20km from the centre and provides supporting documentation.
- 9. Suspension** Suspension may be possible under the terms of this Agreement. You may suspend for a minimum of 1 week at a time. In order to suspend you must contact the Manager, Murray Evans Sports and Aquatic Centre in writing with reasonable notice (at least 30 days unless reasonable grounds with evidence provided) prior to the date of suspension. There is a charge of \$5.00 per week dependant on the type of membership while the agreement is suspended.
- 10. Transfer of Membership** Memberships are transferable to another person. An application must be made to the Manager, Murray Evans Sports and Aquatic Centre in writing and will incur an administration fee of \$5.00.
- 11. Replacement Card Fee** If a Membership Card is lost, stolen, misplaced or destroyed and requires a replacement, a replacement card fee of \$2.00 will apply.
- 12. Additional Fees for Special Service** Some services require an additional fee and these include but are not limited to Personal Training and Swimming lessons and equipment hire.
- 13. Damage to the Centre** Any member/patron who willfully or through their negligence damages the centre or its property will pay for the damage. Members/patrons are responsible for damages caused by their guests and children.
- 14. Breach of terms and conditions** Any Breach of these terms and conditions will result in a warning and any further breach will result in a second warning and your membership may be suspended or terminated. A proven serious breach of the general conditions of entry under 2(a) may result in immediate termination of your membership without warning. In the case of serious offences or criminal activity, police will be notified and management reserves the right to refuse entry in the future.
- 15. Damage and Personal Injury Disclaimer** To the extent permitted by law, the Centre excludes any liability to the Customer in contract, tort, statute or in any other way for any injury, damage or loss of any kind whatsoever (including, without limitation, any liability for direct or indirect, special or consequential loss or damage), sustained by the customer and/or any other person, or for any costs, charges or expenses incurred by the customer, arising from or in connection with the Membership Agreement and/or the services/products provided by the centre, and/or any act of omission of the centre.
- 16. Privacy** Your personal information will only be used in accordance with Somerville House general business objectives and to provide you with the Somerville House Murray Evans Sports and Aquatic Centre's services. You will be able to access your personal information upon reasonable notice given to the Manager, Murray Evans Sports and Aquatic Centre in writing.
- 17. Parking** All car spaces under the Somerville House Murray Evans Sports and Aquatic Centre complex are allocated to staff of Somerville House. The car park is reserved for staff from 7.00am to 5.00pm Monday to Friday during term time. There is an addition to this, in that there are a number of car spaces allocated to staff outside of these times (7.00am to 5.00pm). These areas are marked with signage. Please adhere to these guidelines for the use of the car park at the Somerville House Murray Evans Sports and Aquatic Centre. The Somerville House Murray Evans Sports and Aquatic Centre does not accept responsibility for any parking infringement notices incurred by members/patrons of the centre.
