Enrolment Applications

A non-refundable **\$250 application fee** is required for both day and boarding students and **does not guarantee** a place at the College.

A non-refundable **\$1,000 enrolment fee** is payable and must accompany your signed Acceptance Form. **This fee is not deducted from tuition fees.**

The enrolment fee contributes to the Signum Fidei Bursary Fund to assist students who would not otherwise be able to afford a Nudgee College education.

Master Plan Levy

- **\$1,150 per family.**

This levy contributes to the College's long-term campus vision, funding major capital projects outlined in the Master Plan. It supports the development of new facilities and large-scale improvements that enhance the learning environment and benefit current and future students.

The Nudgee College Foundation - Voluntary Donations

Included on your fee statement is an optional tax-deductible donation historically set at **\$1000**, with **\$600** allocated to the **Building Fund** and **\$400** directed to the **Jack Ross Bursary**.

These voluntary tax-deductible contributions play two essential roles. They help deliver significant campus enhancements that strengthen the College's learning environment, and they provide bursaries that make a Nudgee College education possible for students whose families may not have the financial capacity to enrol. A consolidated tax receipt is issued at the end of the financial year.

Families may add this donation when paying school fees and can opt out at any time. Donations can also be made through the Parent Lounge when setting up your payment schedule or via the link at **give.nudgee.com**.

Other Expenses

• Uniforms*	\$1,600
• IT Devices (Bring Your Own Device)*	\$3,000

** Expenses for uniforms, IT and stationery are for compulsory items and are a guide only. These expenses vary from year to year, depending on your sons' year level and requirements. Co-curricular uniforms will need to be purchased separately depending on your sons' areas of interest.*

Incidental Charges

May include:

- Boarding House recreational activities
- Transport for recreational activities and personal appointments
- Health Centre, vaccinations and pharmacy costs
- Lost or damaged textbooks, library books or laptop (not covered by warranty)
- Pocket money

Fee Discounts

- Two brothers attending at the same time - 10% for 2nd student
- Three brothers attending at the same time - 30% for 3rd student and 10% for 2nd student
- Four brothers attending at the same time - 50% for the 4th, 30% for 3rd, and 10% for 2nd student

To be eligible for a Sibling Discount, a student must be the second or subsequent child attending the College concurrently, having one or both parents in common. This discount is not available to family members outside the sibling relationship, such as step-brothers.

Fees

It is essential for the effective operation of the College, as well as its continued efficient financial management, that fee accounts are paid on time.

Accordingly, parent support in making the payment of school fees a priority is appreciated.

Payment Terms

It is the intention of College Board to set fees once each year.

The College fees are billed annually.

Parents and Guardians of Students in Year 12

Parents/guardians are expected to have paid all tuition, boarding and other sundry charges prior to the end of September. Any payment cycles and plans will be adjusted to end in September. For further clarification please contact the Finance Office via email finance@nudgee.qld.edu.au.

Voluntary Tours

Where school fees remain in arrears and a direct debit/ payment plan has not been set up, a **student will be ineligible** to participate in voluntary school tours.

Overseas Student Health Cover

Overseas Student Health Cover (OSHC) - As required by the Department of Immigration and Border Protection (DIBP), OSHC must be arranged for the entire duration of a student's visa before the student visa being issued. The School does not arrange OSHC for students. Parents are free to choose their medical insurance authority.

Goods and Services Tax

The College is required to comply with the Goods and Services Tax (GST) introduced from 1 July, 2000. The basis on which GST is charged to parents may vary with changes to the GST legislation or its interpretation by the Australian Taxation Office. GST may be charged to fee accounts for the GST component of taxable activities which occur during the school year.

Notice of Withdrawal

Parents are required to provide **one full Term's written notice** to the Principal of a student's withdrawal from the College, or fees in lieu of notice will be charged. This can be sent to principal@nudgee.qld.edu.au.
