INCIDENTAL CHARGES

May include:

- Boarding House recreational activities
- Transport for recreational activities and personal appointments
- Health Centre, vaccinations and pharmacy costs
- Lost or damaged textbooks, library books or laptop (not covered by warranty)
- Pocket money

* Expenses for uniforms, IT and stationery are for compulsory items and are a guide only. These expenses vary from year to year, depending on your sons' year level and requirements. Co-curricular uniforms will need to be purchased separately depending on your sons' areas of interest.

FEE DISCOUNTS

- Two brothers attending at the same time - 10% for 2nd student
- Three brothers attending at the same time - 20% for 3rd student and 10% for 2nd student
- Four brothers attending at the same time - 20% for 3rd and 4th students and 10% for 2nd student

From 2019, when one or more siblings are attending the College at the same time, discount applies to tuition and boarding fees.

FEES

It is essential for the effective operation of the College, as well as its continued efficient financial management, that fee accounts are paid on time.

Accordingly, parent support in making the payment of school fees a priority is appreciated.

ENROLMENT APPLICATIONS

A non-refundable **\$250 application fee** is required for both day and boarding students and does not guarantee a place at the College. A non-refundable **\$1,000 enrolment fee** is payable and must accompany your signed Acceptance Form. This fee is not deducted from tuition fees. The enrolment fee contributes to the Signum Fidei Bursary Fund to assist students who would not otherwise be able to afford a Nudgee College education.

MASTER PLAN LEVY

- **\$800 per family.**

This compulsory levy supports the refurbishment and development of existing College buildings and facilities, as detailed in the College Master Plan.



NUDGENE COLLEGE FOUNDATION BUILDING FUND

- **\$1,000 per year is suggested.**

Voluntary donations to the Building Fund are tax-deductible, so all donors receive a direct benefit, regardless of the amount donated. We encourage every Nudgee College family to make a voluntary contribution to the Building Fund, as your support is a real investment in present and future Nudgee College facilities.

Together with the Master Plan Levy, voluntary donations will accelerate the College's capacity to improve facilities.

EDMUND RICE FOUNDATION LEVY

- **\$140 per year per family** is optional, but helpful in supporting Edmund Rice Foundation projects.

PAYMENT TERMS

It is the intention of College Board to set fees once each year.

College fees are billed annually.

Term 1 fees (one quarter of fees billed), must be paid 7 days from the receipt of fee statement and each subsequent term's fees by the end of April, July and October.

VOLUNTARY TOURS

Where school fees remain in arrears and a direct debit/ payment plan has not been setup, a student will be ineligible to participate in voluntary school tours.

NOTICE OF WITHDRAWAL

Parents are required to provide one full Term's written notice to the Principal of a student's withdrawal from the College, or fees in lieu of notice will be charged.

OVERSEAS STUDENT HEALTH COVER

All overseas students must be covered by Overseas Health Cover. Parents must choose to purchase Health Cover independently.

GOODS AND SERVICES TAX

The College is required to comply with the Goods and Services Tax (GST) introduced from 1 July, 2000. The basis on which GST is charged to parents may vary with changes to the GST legislation or its interpretation by the Australian Taxation Office. GST may be charged to fee accounts for the GST component of taxable activities which occur during the school year.
