- Copy of tax return for applicant/s  
(If you are applying for the 2021 school year you must provide a copy of the tax return for the year ending 30th June 2020)
- Copy of the ATO Notice of Assessment that relates to the tax return above for the applicant/s
- Centrelink benefits - provide copies of recent Centrelink statements and notices – if applicable
- Child Support Assessment – if applicable
- Details of any other funding that will be received (either by yourself or the College) for tuition fees
- If not declaring any Centrelink , Child Support or other funding for tuition fees please complete the attached Declaration

Optional: Any other financial information that would assist in your application for assistance

Applications for Fee Assistance are means-tested. Please use the checklist when submitting an application.

Fee Assistance Applications for 2021 must be received **in full**.

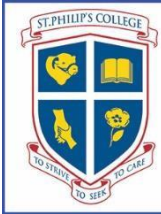
