TUITION FEES

The below fees are considered Tuition Fees.

Enrolment Confirmation Fee **\$1,000**

When a place is offered, parents are required to sign an Enrolment Contract and pay for each newly enrolled student a non-refundable Enrolment Confirmation Fee, which confirms the place for the student.

(The Enrolment Confirmation fee will be refunded if enrolment is cancelled due to visa refusal or provider default.)

Tuition Fees **see schedule**

The cost of tuition is reviewed annually. Parents/legal guardians are notified of tuition fees in writing prior to the commencement of Semester 1 of the academic year. The updated Schedule of Fees is also published on the College's website.

Overseas Student Levy **see schedule**

The Overseas Student Levy applies to all students studying on a 500 visa. It provides funding to the school for educating overseas students for whom the school does not receive Australian Government assistance.

Capital Levy **\$400 per annum**

The Capital Levy applies to all students. Funds derived from the Levy are used to replace, upgrade and maintain capital equipment and facilities other than buildings (e.g. ovals, courts, landscaping and roadways).

Technology Levy **\$116 per annum**

This levy contributes towards the cost of additional software licensing for the College. Included in this levy is a full copy of Microsoft Office Professional and/or Microsoft Windows for installation on a personal computer and the provision of centralised, platform-independent applications where appropriate. *This levy does not include ebook and other digital classroom resources.*

Ironbark Levy **see schedule**

Attendance at Ironbark in Year 9 is compulsory. The Ironbark Levy contributes to the costs of board and lodging at the Ironbark Outdoor Education Centre. Parents of Years 8 and 9 day students are charged the Ironbark Levy each term in four instalments over two years, commencing in Year 8. New Year 9 day students will be charged the total levy in Year 9.

NON-TUITION FEES & OTHER EXPENSES

Music Education through Band and Strings (MEBS) Levy **\$70.00**

MEBS is a compulsory program for Year 5 students. The MEBS Levy is payable if the student does not have an appropriate instrument or wishes to study an instrument other than that which they own. The charge will appear on Semester 1 account or Semester 2 account, depending on which semester the student undertakes the program.

QCAA Moderation Fee **\$780 per annum**

The Moderation Fee, for all students of Years 11 and 12, is levied by the Queensland Curriculum and Assessment Authority for processing the Year 12 Certificate.

International Baccalaureate Fee **see schedule**

A non-refundable registration fee is charged when students enrol in the International Baccalaureate Diploma at the commencement of Year 11. Subsequently, an International Baccalaureate Fee is charged each semester for Years 11 and 12 students enrolled in the International Baccalaureate Diploma. This fee contributes towards International Baccalaureate Organisation examination fees.

Enrolment Application Processing Fee **\$250**

This non-refundable fee is payable to the college when submitting an enrolment application.

Boarding Fees **\$25,132 per annum**

Included in this fee is a laundry service and all meals. Additional charges for medical costs, pharmacy, taxi and travel costs are not covered by Boarding fees.

Boarder sibling concessions are available at the rate of 10% off tuition for the second boarder and 20% off tuition for the third and subsequent boarder.

Student Health Cover **approx. \$550 per annum**

The Australian Government requires all students studying on a 500 visa to purchase Overseas Student Health Cover (OSHC). Please refer to the program length payment listed in the offer details for protection against fee increases.

Please note this may not cover the full cost of medical expenses. Student Health Cover does not cover the cost of medications.

Boarding students must go home for end of term holidays – April (end of Term 1), June/July (end of Term 2), September/October (end of Term 3), and December/January (end of Term 4). The cost of returning home is borne by the parents.

PAYMENT OF FEES AND LEVIES

Discount for Early Payment of Annual College Fees

A 2.5% discount will be granted to parents who elect to pay the full year's College fees by 27 January 2021, as shown on the Term 1 fees statement.

** This discount applies to compulsory fees and levies. Additional charges must be paid by the due date each term.*

Payment by Credit Card

Payments made by credit card (Visa or Mastercard) will attract a surcharge of 0.75%. This surcharge will be automatically calculated at the time of payment.

Please note that American Express is not accepted by the College.

Who is Responsible for Payment?

The parent/s and/or legal guardian/s who have signed the Enrolment Contract with the College are jointly and severally liable for the student's tuition fees and any other costs associated with the student's attendance at the College, unless a Court Order states differently. A copy of any relevant Court Order or other documents stating amendments to the financial and/or parental responsibility arrangements must be provided by the parent/s and/or legal guardian/s to the College.

ALL FEES ARE QUOTED IN AUSTRALIAN DOLLARS (AUD). PAYMENTS WILL BE ACCEPTED IN AUSTRALIAN DOLLARS ONLY. REFUNDS, AS APPLICABLE, WILL BE IN AUSTRALIAN DOLLARS.
